TRUE BILL OF INDICTMENT

IN THE NAME AND BY AUTHORITY OF THE STATE OF TEXAS:

THE GRAND JURY, duly selected, organized, sworn and impaneled as such for the County of Liberty, State of Texas, at the April term, A.D. 2010, of the 259th Judicial District Court for said County, upon their oaths do present in and to said Court that on or about the 6th day of April, A.D. 2010, and anterior to the presentment of this indictment, EDWARD ROSS SHAUBERGER did then and there, with intent to deceive and with knowledge of the statements' meanings, make two inconsistent statements under oath, one of the two statements being necessarily false, the first of such statements being that Edward Ross Shauberger was not an owner of LCST at the time that the statement was made, such first sworn statement being then and there required and/or authorized by law to be made under oath, while the said defendant was then and there under oath, and the first sworn statement was made on or about August 28, 2007 during or in connection with an official proceeding, to-wit: a hearing in Trial Court No. 200749845 in the 55th Judicial District Court of Harris County, Texas, and the second of such statements being that Edward Ross Shauberger was 50 percent owner of LCST from July of 2007 up to April 6, 2010, such second sworn statement being then and there required and/or authorized by law to be made under oath, while the said defendant was then and there under oath, and the second sworn statement was made on or about April 6, 2010 during or in connection with an official proceeding, to-wit: a hearing in Trial Court Cause No. CV0800830 in the 75th Judicial District Court of Liberty County, Texas, and the aforementioned sworn statements were then and there material to the proceedings in which they were made, against the peace and dignity of the State.
